#### Description

#### **General information**

The surface disinfectants are used both for routine disinfection as "prophylactic disinfection" and for targeted disinfection of visibly contaminated surfaces or surfaces or objects that could be contaminated. From the point of view of work organisation, exposure times play an important role. Surfaces that could become sources of infection in the case of rapid successive interventions on patients should be disinfected with fast-acting procedures.

Ready-to-use spray and wipe disinfectant with the novel, water-based active ingredient NEUTRAL+ION®. Free of alcohol, Aldehydes, surfactants and phenols and particularly mild.

#### **Application**

The ready-to-use rapid disinfection is applied to surfaces of all kinds from a distance of approx. 30 cm. Alternatively, the solution can also be applied directly to a lint-free, undyed disposable cloth. Make sure that the surfaces to be disinfected are completely wetted. Then allow to act briefly and, if necessary, remove excess preparation with a lint-free, undyed disposable cloth. Check material compatibility in a concealed area.
