Description

Properties

Dermatologically tested, very good skin compatibility even with very frequent use, no addition of odourants or dyes or other additives, extremely short exposure times, bactericidal, fungicidal, tuberculocidal, limited virucidal, limited virucidal PLUS, virucidal.

Preparation type

Skin-friendly disinfectant for application to the skin and for preparing poultices. Within a very short time, comprehensive spectrum of activity against bacteria incl. tuberculosis, fungi (Candida albicans) and all enveloped viruses such as HIV, HBV, HCV, influenza viruses, etc.

Application

Clean hands before disinfection and allow to dry. Apply a sufficient amount of hand disinfectant to the hands. Keep hands moist during the entire exposure time and add more if necessary. Wet hands completely, taking into account fingernail angles and skin folds.

Hygienic hand disinfection: For hygienic hand disinfection, rub the hands with the solution and keep them moist for 30 seconds according to the exposure times.

Surgical hand disinfection: For surgical hand disinfection, hands and forearms are rubbed with the solution and kept moist for the specified exposure times.
